As per the guidelines issued by Guru Gobind Singh Indraprastha University, New Delhi. in regard to admission under management quota for the academic session 2024-25 available on the university website <http://www.ipu.ac.in/Adm2024brs/adm24brUG310124.pdf>, and with reference to University Circular Nos. GGSIPU/Academic/MQ/2024-25/369 dated 05/06/2024, GGSIPU/Academic/2024/495 dated 28/06/2024, and GGSIPU/Academic/2024/494 dated 28/06/2024, applications(online/offline) are invited for management quota seats for BBA, BCA and BA(JMC) programmes running in the college as per details given below:

1. Number of seats available in each programme:
 - a. BBA = 12(Shift-I) + 12(Shift-II)
 - b. BCA = 06(Shift-I) + 06(Shift-II)
 - c. BA(JMC) = 06(Shift-I) + 06(Shift-II)
2. Start Date for issue of Application form(offline/online registration) is 10th July 2024 (10:00 AM onwards).
3. Closing date for submission of filled-in application form(offline/online) is 31st July 2024 (upto 04:00PM).
4. Duly filled-in application form (online/offline) alongwith the copy of the required documents to be submitted at the reception counter.

Candidates have the following options to apply(online/offline) for management quota admission for the academic session 2024-2025.

1. For Online application, candidate should visit Institute website and apply as per details mentioned under management quota admissions.
2. Application form for applying 'offline' is also available at the reception counter of the institute. (Time: 10:00 AM to 04:00 PM)
3. The application form is also uploaded on the institute's website. Download the form from the website and submit the duly filled-in form directly at the institute's Reception with the registration fees of Rs 2500. (Time: 10:00 AM to 04:00 PM)
