

### **Report:**

The BBA department of JIMS VasantKunj organized an Industrial Visit to Mother dairy for the BBA students on 16th October, 2019. Mother Dairy is an Indian company that manufactures markets and sells milk, milk products and other edible products. Mother Dairy milk has a market share of 66% in the branded sector in Delhi where it sells 2.5 million liters of milk daily and undertakes its marketing operations through around 1400 retail outlets and over 1000 exclusive outlets of Mother Dairy. The objective was to provide students an insight regarding internal working of Mother Dairy and opportunity to learn practically through interaction regarding the Milk Collection, Transportation, Testing, Processing and Manufacturing of other dairy products.

To make students aware and have better understanding of processes technical instructor started with the description of Procurement of milk where he explained how the milk is being collected through insulated road/rail tankers at very low temperature thus retaining the freshness of the milk. The milk Collecting containers are called Silos. After the collection of milk in the plant the milk is subjected to 23 stringent quality test (few of the tests were demonstrated as well) these include organoleptic, physiochemical and microbiological tests. The next steps include the Processing of the milk where different devices used for processing were shown to the students. The important processes include clarification were the instructor explained the working of clarifier which is used to remove the dust particles that are visible to the naked eye. After Clarification, the milk is subjected to Standardization which is done to make the uniform composition of the milk so as to deliver the milk to the consumer's as per the prescribed norms of FSSAI. Homogenization of ... Homogenization which the large fat globules present in milk are broken down into tiny droplets. Homogenization improves palatability of milk and is easily digestible. The next step of processing of milk is pasteurized which involves heating of milk at 72 degree Celsius. This process kills all the pathogenic bacteria in the milk.

The final stage is the **Distribution of the milk**; this is done after processing of the milk where milk is dispatched in hygienic & Sterilized milk tankers packed in food grade materials and transported under cold chain to our nearest milk shops.

Finally the students ended their visit by having a look and understanding the functioning of the processing units which the instructor had discussed with the students through video while he was describing the whole functioning of the plant. **Exposure to Solar Panel & Nano Water tank** was very exciting & fruitful for students. The tour came to an end with the distribution of milkshakes and ice-cream to all the students and faculties.


The visit was very useful for the students as they could now relate their theoretical knowledge with the practical exposure which they have gained after visiting this plant. It was a good learning experience for the students

Today, Mother Dairy manufactures markets & sells milk and milk products including cultured products, ice creams, paneer and ghee under the Mother Dairy brand. The Company also has a diversified portfolio with products in edible oils, fruits & vegetables, frozen vegetables, pulses, processed food like fruit juices, jams, etc. to meet the daily requirements of every household.

Mother Dairy is an ISO 9001:2008 (QMS), ISO 22000:2005 (FSMS) and ISO 14001:2004 (EMS) certified organization. 





It uses roadways transportation for the delivery in various areas (defense sector, stores, etc). In North India, it has approximately 170 agents. However, it lacked health safety measures in an atmosphere of high chemicals. Hence, after the observations so made, the tour came to end with discussions and snacks provided by the industry.


